Discussed a resolution for the parade route for this year's celebration. A motion was made by Gold, and 2<sup>nd</sup> by Northup to approve the resolution for the parade route for the 150<sup>th</sup> Celebration being held in 2009. Gold, Newberry, and Northup AYE. Ellison ABSENT.

A motion was made by Newberry, and 2<sup>nd</sup> by Gold to donate \$300 to the Dallas City Elementary PTO. Gold, Newberry, and Northup AYE. Ellison ABSENT.

A motion was made by Gold, and 2<sup>nd</sup> by Northup to donate \$300 to the Illini West After Prom. Gold, Newberry, and Northup AYE. Ellison ABSENT.

Esther Newberry left the meeting at 6:00 P.M.

Chris Classen reported that a lift station pump had to be cleaned out.
